III. OLD BUSINESS

- a. Application for the USDA Rural Business Development Grant for a new downtown parking lot was successfully submitted!
- b. Facade Improvement Grant: submitted a grant application for \$20k from the Fund for Ravenswood.
- c. Design Committee's decision on pursuing a Mural Mosaic paired with an Arts Grant:
- i. Community Arts Project Support 50% match up to \$20k. Local governments are eligible. Art experiences to the public. Due April 1. (Could pair with the T Mobile Grant, or the Jackson County Community Foundation or PACF grant to cover the \$10k match. Due March 15 or Sept 15.)
- ii. Other Grants: T Mobile for \$50k due March 31! They will fund projects that foster local connections, like technology upgrades, outdoor spaces, the arts, and community centers.

iii. Youth Engagement Through Public Art 25% match up to \$5k; support for visual two- and three-dimensional public art projects that engage local youth in the planning and/or implementation of the project. Projects must be in a public place. Due April 1 or Oct 1. d. Redesign of the business directory
