

RESOLUTION

Appointing and Confirming Members to the Harvest in the Wood Festival Committee

WHEREAS, the City of Ravenswood, West Virginia recognizes the importance of promoting community events that celebrate local culture, heritage, and traditions; and

WHEREAS, the establishment of the Harvest in the Wood Festival Committee is deemed necessary to organize, coordinate, and oversee the annual Harvest in the Wood Festival; and

WHEREAS, the Harvest in the Wood Festival will provide opportunities for local businesses, artisans, and residents to showcase their products and talents, thereby enhancing community spirit and economic development;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Ravenswood, West Virginia, as follows:

1. **Establishment of the Committee:**

The City Council hereby establishes the Harvest in the Wood Festival Committee (hereinafter referred to as "the Board").

2. **Purpose and Duties:**

The Board shall be responsible for planning, organizing, and managing the annual Harvest in the Wood Festival. Duties include, but are not limited to, coordinating with vendors, securing event locations, managing budgets, and promoting the festival to ensure its success.

3. **Composition:**

The Board shall consist of eight (8) members appointed by the Mayor and confirmed by the City Council.

4. **Appointments and Terms:**

Initial appointments shall be for a (1) one-year term.

5. **Meetings:**

The Board shall meet monthly, or as needed, to effectively plan and coordinate the festival. Special meetings may be called by the Chairperson or a majority of the Board members.

6. **Officers:**

The Board shall elect from among its members a Chairperson, Vice-Chairperson, and Secretary. Officers shall serve for a term of one (1) year and may be re-elected.

7. **Funding and Support:**

The City Council shall approve an annual budget for this committee during annual budget presentations. Committee may approach city council for additional funding, if needed, throughout the fiscal year.

NOW, THEREFORE, BE IT RESOLVED, that the Common Council of the City of Ravenswood, hereby approves Mayor Joshua Miller's nominations of the below listed members of the Harvest in the Wood Festival Committee, as follows:






